And with that, we are providing some information in the section below on COVID-19. Please pay special attention to the links in the section below with a wealth of information on the virus and resources available to you.


We are very appreciative of everyone's efforts in ensuring social distancing at this time.

Novel Coronavirus (COVID-19) Information

By now, we're sure that you have learned that the Centers for Disease Control and Prevention (CDC) is responding to an outbreak of respiratory disease caused by a novel (new) coronavirus that was first detected in China and which has now been detected in more than 100 locations internationally, including in the United States. The virus has been named "SARS-CoV-2" and the disease it causes has been named "coronavirus disease 2019" (abbreviated "COVID-19"). And let's just say that it has shaken things up!

Just this afternoon, Baltimore City announced its second confirmed case of COVID-19, and it's certain to have many more cases in the very near future.

Baltimore City Council Legislative & Community Updates

Below are the recent legislative updates by Baltimore City Council:

- As mentioned previously, Council President Scott introduced a <u>Charter Amendment that would remove the appointed members of the Board of Estimates</u>, reducing the size from 5 to 3 members. Per President Brandon Scott: "Reducing the Board of Estimates to the three elected members, all with equal weight to approve or reject City contracts involving taxpayer dollars, is one way we can clean up City government and make it more efficient and more supportive of our local communities."
- Council President Scott continues to work on implementing his <u>Legislative and Policy Proposal (2019-2020)</u>. Several policies are making their way through the legislative process with three signed into law. You can find an update on the status of these policies in the <u>Policy Tracker</u>.
- All Council Hearings have been cancelled for the next few weeks. <u>Click Here</u> for the
 calendar for all upcoming Council Meetings and Hearings. All hearings and council
 meetings are open to the public. You'll need a photo id to enter City Hall.

Below are recent community updates regarding the COVID-19 outbreak:

- On Saturday, March 14th, the first case of COVID-19 was confirmed in Baltimore City. See Council President Scott's <u>statement here</u>. Council President Scott and the City Council have also called on the <u>Governor</u>, <u>Health Commissioner and Public and Private</u> <u>Institutions to Come Together to Support Vulnerable Populations</u>. President Scott wants to make sure that all residents are supported during this time.
- This morning, March 16th, Governor Hogan issued an <u>executive order</u> regarding public gatherings.
 - All bars, restaurants, movie theaters and gyms across the state will be closed, effective at 5pm today.
 - Drive-through, delivery and carry-out services can continue.
 - Gatherings larger than 50 people are prohibited.
 - Utility companies may not shut off service to residential customers.
 - No late fees will be assessed on utilities.
 - No tenants will be evicted during the State of Emergency.

- Baltimore City Schools are closed from today until Friday, March 27th.
- All <u>Pratt Library branches</u> are closed until March 30th. The digital library is still available.
- All <u>BCRP Rec Centers</u> are closed until Friday, March 27th. Forty (40) Rec Centers will serve as locations to get meals. These will be grab-and-go meals, individuals will not be allowed to stay and eat in the Rec Centers.

Midtown Community Benefits District Update Addressing Coronavirus (COVID-19)

In order to protect our staff and communities during this continued public health emergency, Midtown began limiting its service effective today, Monday, March 16th at 7am.

In order to limit staff members' exposure, we will be reducing the daily team size, and therefore, service will be addressed differently. Our team will be focused on emptying the 150+ public trash cans in the district, and will service the streets, gutters, sidewalks, and parks in the neighborhoods on a rotational basis. We will closely monitor the district, and address any high traffic areas or emergency situations as best we can. Bulk trash removal will not be available until further notice, and the community is encouraged to call 311 for that service.

We ask that community members utilize service@midtowncommunity.org to alert us to any areas of high concern, and we will address them as we are able. (Please note our Facebook page is not monitored for service requests.) You may also call 410-528-1512, but please know we may not have continuous access to calls.


We remain in constant communication with our city agency partners, and will continue to provide you with updates as they are available.

Please know that it is our intention to be back up to full staff and full service as soon as it is safe for us to do so. We are proud of the work we do in our communities, and nothing means more to us than making sure the district receives the attention it deserves. Safety Meeting Follow-Up: Safety Tips

To re-emphasize the importance of safety, below are the **Safety Tips** as provided during the February 4th BPD Safety Meeting:

- When walking, please do not get so distracted by your cell phone that you're not paying attention to your surroundings.
- Try not to walk with your cell phone up to your face or in your hands if possible. Keep it in your pocket or out of sight.
- · Walk in well-lit areas whenever possible.
- Please do not walk down the street holding your car keys in your hand. If possible, try to keep them in your pocket and try to get into the habit of unlocking your car doors while

/

your keys are still in your pocket. Familiarize yourself with your vehicle's remote control features.


- Separate your vehicle and house keys.
- If you think you're being followed, go into an open business if possible and let someone know.
- Do not leave items or empty boxes inside of your vehicle in plain sight.
- · Do not leave any valuable items in your vehicle overnight.
- Always make sure someone is aware where you are going. When possible, utilize your smartphones feature and share your location with someone you can trust.
- Invest in a doorbell security camera system of your choice (cannot recommend brand).
- If you have a home alarm system, please make sure you set the alarm when you leave home.
- If you see someone or something suspicious, please make sure you notify the police.
- Use your smartphone to take pictures of your electronic devices' serial numbers:
 computers, televisions, smartphones, tablets, etc. (When purchasing these items, the
 serial number can be located on the box with the bar code). Once you have photographs
 of your serial numbers, be sure to email them to yourself and to save the photographs to
 the cloud---that way they are available if needed.
